Photographic / Video Consent Form

Purpose

The purpose of this form is to outline the expectations of our school community regarding photography and video recording. This form follows the guidelines provided by the eSafety Commissioner for Young People and AUSdance Victoria, complies with the *Child Wellbeing and Safety Act 2005 (Vic)*, and relates to the RBG Child Safe Policy.

Occasionally, the Ringwood Ballet Group (RBG) may record photographic and/or video images of students at our school, for the purposes of:

- Digital publication of images on the school website and/or social media sites such as Facebook and Instagram;
- 2. Printed images in our school information booklet, calendars, and any other publications that we produce;
- 3. For teaching, monitoring and/or other educational purposes;
- 4. Occasional posting of RBG students' achievements and participation at competitions and other events on the RBG private Facebook page, which is only accessed by members.

Please note:

- Consent is the informed and freely given agreement to engage in an activity, or permission for a specific thing to happen.
- You should always seek consent before sharing a photo or video.
- Consent is ongoing. Even if someone has said yes to an image being posted, they can change their mind and retract their consent.
- If someone asks you to remove a photo or video, you should do it no questions asked.

Restrictions

- Photography/video recording is not allowed in the change rooms at any time, regardless if it is at the studios or external venues.
- Photography/video recording by parents is not allowed in the studios during class, except with the permission of the Artistic Director.
- Photographers from outside the school community should only take photographs/video recordings of children when consent has been given.

- Photography/video recording of concert rehearsals and performances at the theatre is not allowed, but photographs may be taken within the rest of the theatre environment.
- Photography/video recording of your own child is permissible at other times within the confines of the school or venues being used by the school. Photography/video recording of groups of children in these situations should only be done with the consent of all others involved in the photograph/video.

This policy will be reviewed at least every three years. Next review date: February 2026.


